- The article should include abstract (200–250 words), key words, introduction, text, conclusion and references.
- The articles should be sent in word file with font 14, along with the PDF version with a size of 15 to 25 pages (300 words per page), via email or the conference website to the secretariat.
- The submitted articles must be in line with the themes and topics of the call and have not been presented or published before in another conference or journal.
- Articles out of the call will be evaluated after the approval of the secretary of the conference.
